- Consumer Redress
- Sanction Offender
- Inform other potential victims
- Rulemaking
- Government enforcement
- Private enforcement

## **Private Litigation**

- Cost
- Time
- Transience of military personnel
  - Venue may be far from current residence
  - May execute deployment or PCSO before ct date
- Unpredictable results
- Appeal de novo of NC Small Claims Actions
- Difficulty in getting legal representation
- Forced arbitration (esp. w/ auto sales & finance)

Private Litigation: Sometimes it works

  - USMC Times 22 Apr 2011: Chase to pay \$48 million

- FTC Military Sentinel / Consumer Sentinel
  - Gov't lawsuit unlikely in absence of egregious conduct, widespread harm
  - Referral to other agencies
  - Inform Congress
  - Rulemaking
    - Particular interest currently in auto finance, esp BHPH lenders exempted fro CFPB. Enhanced rulemaking.
    - Public comment

## U.S. Department of Justice: SCRA Enforcement

- Veteran's Benefits Act 2010
  - DoJ Enforcement of SCRA (50 USC app 597)
    - Pattern or practice of SCRA violation
    - Violation raises issue of significant public importance
  - Fine (\$55K 1st viol, \$110K subsequent viols)
  - Equitable / declaratory relief
- Warning/ advice calls



#### USDOJ: SCRA Enforcement



- Mortgage Foreclosure
  - NC Gen Stat 45-21.12A, 45-21.16c,d
  - SCRA 533 protections grafted onto state law
- Interest Rate Reduction
- Lease Termination
  - Phony "rent concession" leases
- False service affidavit
- Other



#### **Housing Inspector Authority**

- Deny / approve / revoke bldg permits
- Inspect work in progress
- Order work immediately stopped
- Order defects corrected
- · After hearing, enforcement actions for noncompliance
- Criminal penalties

#### **Landlord Duties**



- Comply with building / housing codes
  - www.Municode.com
  - Local code may adopt state codes
  - Onslow County: Chapter V article III : Minimum Housing Standards
- Make repairs, keep fit & habitable
- Keep common areas in safe condition
- Provide smoke detectors, replace after notice
- Notify tenant of contaminated water (if landlord
- Duties concerning CO2 detector repair /

#### **Landlord Duties**

- Repair / remedy imminently dangerous conditions in reasonable time after knowledge or actual notice. Includes:
  - Unsafe wiring, steps, roof, chimney
  - Lack of potable water, no locks on exterior doors
  - Broken windows, lack of locks on 1st floor windows
  - Lack of heat (1 Nov -31 March)
  - No operable toilet, tub or shower
  - Rat infestation due to structural defects
  - Excessive standing water, sewage, flooring due to plumbing leaks or inadequate drainage

#### NC State Bar



- Complaints
  - . Violations of Rules of Professional Responsibility
  - Bar counsel assigned
  - Investigation conducted if needed, respondent responds
  - Referral to Grievance Committee

    - Letter of caution, warning, admonition, reprimand, censure
       Referral to Disciplinary Hearing Commission
  - DHC Hearings on the merits and sanctions

  - Distribused
     Letter of caution, warning, admonition, reprimand, censure
     Suspension up to five years (May stay on conditions)
     Disbarment

  - Appeal to NC Court of Appeals

## **Armed Forces Disciplinary Control Board**



- · Joint Forces Order
  - AR 190-24 / OPNAVINST 1620.2A
  - AFI 31-213 /MCO 1620.2D
  - COMDTINST 1620.1E
- Inspector / Board President
- Procedures
  - Warnings, hearing, notice and opportunity to be heard
  - Emergency cases: Hearing after off-limits designation

#### Persona Non Grata



- Issued by Installation CO
  - Contact installation Inspector
- Federal trespass statute: 18 USC 1832
  - Enter installation for purpose prohibited by law or regulation
  - Reenter after receiving PNG letter
  - Fine and 6 months imprisonment

#### Better Business Bureau



- Conciliation
  - Promotes discussion so parties can resolve themselves
- Mediation
  - Trained mediator guides parties to resolution
- Arbitration
  - Parties agree to arbitration. Arbitrator decides.
- Measuring / grading businesses

#### Better Business Bureau Accreditation

- Commitment to good faith resolution of complaints
- Commitment to BBB Code of Business Practice
  - Don't lie, cheat, steal, mislead
  - Free from gov't action demonstrating significant failure to support BBB principles
  - Maintain at least a B average
  - Cooperate w/ BBB in dispute resolution
  - Pay dues
